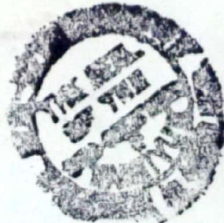

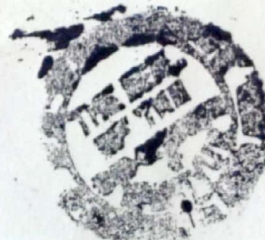
1. Name and Registered Office of the Trust: The name of the trust shall be " **EDISON EDUCATIONAL TRUST**", and the registered Office of the Trust shall be situated at , VEMANDAMPALAYAM VILLAGE AND POST, NAMBIYUR-TALUK, ERODE-DISTRICT, PINCODE - 638462, bearing S.F.No.230, which may be shifted from time to time to such other place or places, as trustees may deem fit and proper at their discretion.

2. The objects of Trust: The objects of the Trust shall be-

- i. To establish, promote, set-up, run, maintain, takeover, assist, finance support in setting up and/or maintaining and/or running Nursery, Primary, Middle and Higher Secondary School/Schools, CBSE(Central Board of Secondary Education) schools, ICSE(Indian Certificate of Secondary Education) schools, IGCSE(International General Certificate of Secondary Education) School, IB(International Baccalaureate) School, Residential Schools, Art, Craft and Science Schools, Colleges such as Technical, Vocational, Professional of any other description such as Arts, Science, Commerce, Engineering, Medical, Para-Medical Science, Dental, Agricultural, Polytechnics Teachers Training College/Institute and/or other educational institutions of higher studies and research for the benefit of the poor and deserving people, without any motive for profit making.

- ii. To establish, maintain and run Creche, Libraries, Hostels, Reading rooms, Dormitories, and all other facilities as are calculated to be use in imparting education to the public and proper running of the Educational Institutions.
- iii. To undertake and promote fundamental and education research work in all subjects, including publications for the purpose thereof.
- iv. To give scholarships, stipends, prizes, rewards, allowances and other financial assistance or help in cash or kind to the poor and deserving students with a view to help them in pursuing their studies in schools and college, educational institutions.
- v. To promote, organize, administer, establish, support, maintain and/or aid to any person, institutions or society or organizations whatsoever having for its objects of charitable purpose and to incur expenditure in connection therewith.
- vi. To promote, assist and/or maintain all activities by whomsoever carried on or wherever carried in India in conformity with the objects of the trust and as are conducive to the well being and general welfare of the nation or conducive for the advancement of any object or object of general public utility not involving/carrying on any activity for profit.
- vii. To procure gifts, medicines, clothing, equipment and food stuffs and apply for grants and aids in cash or in kind from various agencies and government departments.

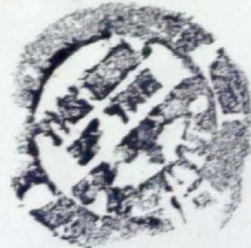

- viii. To award grants, scholarships, fellowships and similar financial assistance or encouragement for the advancement of research in educational field.
- ix. To give, provide and/or render help and assistance in cash or kind to the poor and/or destitute people, widows, etc. To start home for the aged and destitute and orphans to help the needy, and to promote physically, intellectual and spiritual growth of the children.
- x. To give, provide and/or render help and assistance to and/or implement any scheme for providing livelihood and upliftment of the poor.
- xi. To promote peace, social justice, National Integration and religious harmony among all.
- xii. To start training centers for the blind, physically handicapped, orphans and women in order to provide them opportunities for gainful self-employment.
- xiii. To establish, promote, set-up, run, maintain hospitals, charitable dispensaries, maternity homes, child welfare centers for rendering or providing medical relief and/or aid to the suffering humanities.

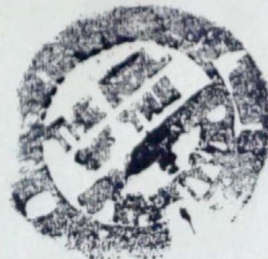

- xv. To give, provide and/or render monetary or other help and assistance for the relief of persons and animals affected by natural and other calamities such as Flood, Fire, Famine, cyclone, Earthquake, Tsunami, Storm, Accident, and Pestilence, Drought, Epidemic, unbearable cost of living and the like, and to give donations, subscriptions or contribution to institutions, establishments, centers, or persons doing relief work on such occasions.
- xvi. To conduct fund raising programmes to augment funds for the above purpose and to solicit, receive, hold and disburse funds from overseas and India to promote the object of the trust.
- xvii. To receive any sum or sums of money as gift or donations in cash or kind or subscription given to or acquired by any other means and to spend in fulfillment of all or any of the objects of the Trust.
- xviii. To do all such other lawful acts as may be necessary or incidental and conducive to the attainment of the above objects or any one of them.
- xix. The trust shall be open to all, irrespective of caste, creed, community or religion and sex.
- xx. To acquire, purchase, hire, exchange, sell or lease any movable or immovable property to further the objectives of the Trust.
- xxi. To above objects are independent of each other and the TRUSTEES may from time to time, apply the funds of the trust in carrying out all or any of the objects of the trust.

xxii. The objectives of the trust as set out herein shall in no way be limited or restricted by reference to any other clauses in this constitution unless otherwise indicated. The order in which the objectives appear does not determine the importance or preference thereof over each other unless specifically stated.

3. Trust Fund: In order to effectuate the said objects of creating a TRUST, the FOUNDERS have delivered to and made over to the TRUST a sum Rs.10,000 (Rupees) to have and hold the same and all other property or properties that may be **acquired in future** out of the same or otherwise may hereafter be subject to the trust (hereinafter called "the TRUST FUNDS") for the objects and purposes and uses herein expressed with the powers on the terms and conditions of and concerning the same.

4. The Trustees: The FOUNDERS as enumerated in the Table hereunder hereby constitute and appoint themselves as the TRUSTEES for life, and they shall hold the following office of the Trust initially for (3) Three years, and all the Trustees shall collectively constitute the BOARD OF TRUST.

5. Rights and Duties of Trustees:

- 1) Each Trustee shall have one vote at every meeting.
- 2) All the Trustees shall be entitled to participate in the meetings and functions and gatherings of the Trust.
- 3) All the Trustees shall have right to inspect the books of accounts, book containing minutes of proceedings of general meetings on any working day during business hours by giving reasonable notice.
- 4) All the trustees shall be bound by rules and regulations and by-laws of the Trust which may be framed by the President from time to time.

6. Disqualification of Trustees:

- 1) No persons, being –
 - a) an undercharged insolvent; or
 - b) convicted of an offensive involving moral turpitude; or
 - c) of unsound mind; or
 - d) a minor;

shall be eligible to be a trustee.

- 2) A persons shall cease to be a trustee in any of the following events:
 - a) if he/she dies; or
 - b) if he/she becomes bankrupt; or
 - c) if he/she becomes insane or otherwise becomes incapable to act; or
 - d) if he/she resigns his/her office or if he/she is in the opinion of a majority of his/her co-trustee after an enquiry caused to be conducted by them found him/her guilty of breach of trust, gross negligence or dereliction of duty.

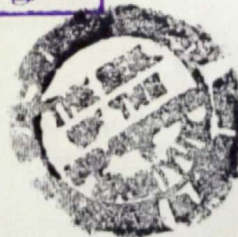

7. Board of Trust: The affairs of the Trust shall be managed by the President. These Office-bearers of the Trust shall be elected by way of election or by nomination as decided with the authority of the president. Besides, also the President shall appoint advisors and form committees for a period not more than one year for a specific purpose, and appoint conveners to these committees as the Board of Trust may deem necessary.

8. Powers of Board of Trust :

- 1) The President will have full power and authority to administer the Trust, its properties and affairs and to do all acts, deeds and things that are calculated to fulfill the objectives of the Trust for which the trust is established.
- 2) The President shall have power to appoint, take disciplinary actions and terminate Managers, Secretaries, Clerks and other Personnel and Staff for running the various institutions of the Trust from time to time and for managing the affairs of the Trust.
- 3) The President shall accept in the name of the Trust any donations, contributions in cash or kind from the general public firm, company, corporation, association, institutions of trust or from TRUSTEES themselves, but no TRUSTEE is competent to collect donations or spend any of the trust amount for any purpose individually without the concurrence of the Trust by way of resolution.

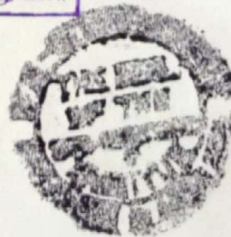

- 4) The President shall have power to decide and stipulate conditions that are to be complied with by the institutions or persons to whom the trust wants to render financial or other aid.
- 5) The President shall constitute committee either among themselves or from general public for the purpose of regulating or carrying on various affairs relating to the conduct of the Trust, but the tenure of such committees shall not exceed one year from the date of its formation.
- 6) The power to appoint new or additional trustees shall vest on the President.
- 7) The President may from time to time form schemes and rules and regulations to carry out the objects of the trust and for managing the trust and its institutions otherwise for giving effect to the object and purpose of the trust and vary the same from time to time as the trustees may in their discretion deem fit and proper.
- 8) The President shall have a power and their uncontrolled discretion, instead of acting personally, to employ and pay agent to transact any business or to do any act whatsoever in relation to the Trust of these presents.

- 9) The President shall have full power to compromise or compound all actions, suits, and other proceedings and settle differences and disputes touching the Trust Estate and/or the Trust properties and to refer any such differences of disputes to arbitrations and to adjust and to settle all accounts relating to the Trust Estate and/or the Trust properties and to all other acts and things fully effectually without being liable or answerable for any confide loss occasioned thereby.
- 10) The President shall have a power to acquire and purchase movable or immovable properties and to make improvement, construct, demolish and reconstruct building and to sell or dispose any of its land and/or building for the use and benefit of the Trust in case of necessity.
- 11) The President shall also have power to grant lease of the immovable property or properties belonging to the trust and to take on lease any immovable properties for the use of the trust, for the time being and from time to time either from year to year or for any fixed term or for any terms of years or on monthly tenancies at such rent and subject to such covenants and conditions as they may think proper and also accept surrenders of lease and tenancies and generally manage the same in such manner as they think proper.

- 12) The President shall have power to acquire any immovable property in exchange for same other property or partly in such exchange and partly for other considerations.
- 13) The President shall have power to levy any fees or charges from the students, apprentices, patients and other benefiting from the institutions and establishments maintained and conducted by the trust for the purpose of expenditure and not with any profit motive and the TRUSTEES shall have power to exempt deserving students, apprentices patients and others from payment of any fees or charges that may be fixed by the Trustees from time to time.
- 14) The President shall have power to take all the steps that may be reasonable, necessary or required for the preservation of the trust, its properties and its title.
- 15) The President shall have power from time to time to declare that the whole or any portion of the surplus income, if any resulting from carrying out of the various objects of the trust, to be part of Capital shall from part of the trust fund and be treated henceforth for all purposes as forming part of capital money. Any surplus remaining after meeting the expenses of carrying out of the objects of the trust and which has not been converted as capital as aforesaid may be utilized for meeting the expenses of the subsequent years in respect of the trust.

- 16) The President shall have the power to do and perform all things required necessary to be done or performed for the purpose of managing the Trust.
- 17) The President shall amend and rescind rules and regulations of the Management and administrations of the trust and its various institutions. However the rule framed shall be in accordance with the objects for which the Trust is established.
- 18) It shall be lawful for the President to take over the management of any other trust affairs, schools, hostels, educational institutions and its properties, and to carry out the objects of the trust amalgamated with this trust and also to promote or carry on the affiliation or amalgamation of such other trust and its institutions.
- 19) All the properties of the trust as and when acquired whether movable or immovable shall at all times stand vested in the President.

9. President:The President shall preside over all meetings of the Board of Trust. He shall have power to convene special meetings of the Board of Trust whenever he considers it necessary. The President shall exercise a general supervision over the affairs of the Trust. The president shall be the person to enter into contracts approved by the Board of trust, representing the Trust. All legal proceeding should be instituted and continued or defended, by the President who shall sign the documents and papers and vakalats relating thereto in the name of and on behalf of the trust. President shall have a casting vote only in case of tie, when he presides over any meeting. He shall operate the Bank Accounts in conjunction with the General Secretary or the Treasurer of the Trust.

10. Secretary:

- 1) The Secretary shall look after the day to day affairs as resolved and passed by the Board of Trust. He shall ex-officio hold the office of Correspondent of all the educational institutions run and managed by the Trust. He shall incur all expenses in connection thereto.
- 2) The Secretary will be in charge of the office of the Trust amongst others do the following acts and things.
 - a) To check and verify accounts in the cash book and sign the same.
 - b) To sign and issue notice for the meeting of the Board of Trust and its Annual Meeting

- c) To Look after and collect all correspondence relating to or in any way concerning the Trust other than this allocated to any trustee or trustees in charge of any department of the society.
- d) To keep or cause to be kept in proper order and custody all documents and all papers and files belonging to the Trust.
- e) To operate on Current/Savings Account in one or more bank or banks as approved by the Board of Trust in conjunction with the President or Treasurer of the Trust.
- f) To sign in token of sanction of all vouchers for necessary expenses of the trust with the limit sanctioned by the Board of Trust before payment by the Treasurer.
- g) As a correspondent of the educational institution run by the trust, he shall be responsible for entire administration of such institutions. He should make him available in the School premises at least two days a week. He shall act according to the decisions and direction of the Board of Trust or the School Committee constituted by the Board of Trust.

11. Treasurer:

- 1) To receive donations in cash and records the receipt in the cash book maintained for the purpose.
- 2) To arrange for investment of surplus assets of the Trust as approved by the Board of Trust.
- 3) To operate an Current/Savings Account in one or more bank or banks as approved by the Board of Trust in conjunction with the President or General Secretary of the Trust.
- 4) To submit all books and papers relating to the Trust's receipt and expenditure, cash books, bank pass books etc., to the Secretary and the President of the Trust once in a month for his scrutiny and signature.
- 5) To prepare yearly accounts of receipts and expenditure and have the same audited by the Auditor appointed by the Board of Trust and approved at the general meeting and present the same before annual meeting of the Trust.

12. Election of Office bearers:

- i. The President, Secretary, and Treasurer of the TRUST shall be elected or nominated once in three years by the trust members.
- ii. All the trustees shall be entitled to vote for the election to the Office bearers.
- iii. In case there is no contest, the candidates duly nominated shall be declared unanimously elected to the post.
- iv. In case of any contest for any of the post, the election shall be by Secret Ballot.

- v. The President, in consultation with the Trust members, shall announce the election, and an Election Officer for the purpose of conducting election shall be appointed by simple majority of the Trust members in the meeting of the Board of Trust.
- vi. No Trust member is eligible to file nomination for more than one post or to propose or to second more than one nominee for the same post.
- vii. Scrutiny of the nominations shall be done by the Election officer.
- viii. Election, if necessary, shall be conducted during the Annual meeting of the Board of Trust.
- ix. The Election Officer shall declare the results of the election at the Annual Meeting of the Board of Trust.
- x. **Term of Office:** The Elected office-bearers shall hold office for a term of Three (3) years.
- xi. In the event of the resignation or death of any Office bearer, another Trust member may be co-opted by the President to fill the vacancy. Such a co-opted member will hold office till the next Annual Meeting.
- xii. **Removal of Office bearers:** Any office bearer of the Trust shall be removed from the respective office, on a resolution passed by the 60% majority of the total strength of the Board of trust at a special meeting convened on the requisition given by 60% of the Board of Trust.

13. Borrowing Powers: The president shall have power to borrow money from individuals, Corporate Bodies, Bank and/or other Financial Institutions with or without securities and upon such conditions that the BOARD OF TRUST deem fit and proper.

14. Vacancies:

- 1) In the event of any vacancy being caused for whatever reason in the office of the Trustees, they shall be filled in the manner hereinafter set forth.
- 2) On any vacancy arising in the office of a Trustee for any reason of death of any of the Trustees, his/her nominee from among his/her family members shall be appointed by the President with the consent of the majority in the place of the deceased trustee.
- 3) In the event the number of Trustees of the trust falls below the minimum number of four Trustees, the President shall meet within 15 days for the purpose of filling up the vacancy and the Board shall not be competent to transact any business other than carrying on necessary existing activities of the trust unless and until the minimum number of four Trustees is filled up.
- 4) The TRUSTEES shall be at liberty to retire or resign at any time without assigning any reason but on giving one-month notice of his intention to do so to the President of Trust and in case, he himself to be the President, then at least 15 days notice to the BOARD OF THE TRUST.

- 5) Such a letter of resignation will be placed at a meeting of the Board of Trust especially convened for this purpose within 10 days from the date of receipt of the letter. No resignation shall be deemed to have taken place until accepted at the said meeting.
- 6) Similar procedure will be followed in the case of any casual vacancy due to death or incapacity of a trustee.

15. Administration:

- 1) The Administration, direction and management of several institutions and establishment in terms of the Trust hereby created shall be subject to the supervision, direction and control of the BOARD OF TRUST.
- 2) The TRUSTEES shall not be entitled to any remuneration for the discharge of his function as a TRUSTEE. In case the TRUSTEE is called upon to discharge any function other than of a TRUSTEE he shall be paid such remuneration as may be decided by the President from time to time.

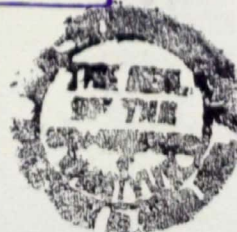

16. Banking and Accounts:

- 1) The President shall be entitled to open, add and maintain a bank Account or Accounts in the name of the trust or its institution namely "**EDISON EDUCATONAL TRUST**", or in the name of any of its other institutions run or managed by the trust, at such bank or banks as the trustees may from time to time decide and may at any time pay or cause to be paid any monies to the credit of any such account or accounts and either by way of fixed deposit or Current account or Savings Account or any other account, any such account may be operated only by the President.
- 2) No amount or fund of the Trust shall be spent by any of the TRUSTEES directly without crediting the same into the Bank's account of the Trust.
- 3) The accounts of the trust shall be kept properly of all monies received and expended by the trust and of the properties, credit liabilities of the trust.
- 4) All the books and registers relating to the Trust shall be kept at the Registered Office of the Trust only and they shall be open to inspection by the President.
- 5) The accounts of the trust shall be annually audited by a chartered Accountant appointed by the President and the audited statement of amount and Auditor's Report thereon shall be placed before the Board of Trust for its approval and adoption within three months from the closure of Financial Year.

17. Application and Investment of Trust Funds:

- 1) All the income of the Trust shall be utilized only towards the object of the trust.
- 2) The President shall apply the trust monies effectively in one objects or some of the objects of the trust in preference to the other objects, and they shall also have the power to discontinue the application of the trust funds to an object and divert the funds to another objects.

- 5) All funds, as and when acquired shall be invested in such manner as may be approved by Section 13(1) (d) read with section 11(5) of the Income Tax Act 1961.

- 6) The TRUSTEES shall after providing for the above mentioned payments and disbursements, apply and utilize the net income or the corpus of the Trust funds for the benefit of the citizens of India without any discrimination on the ground of religion, sect, caste or creed or accumulate after complying with the provisions of the Income Tax Act 1961.
- 7) Alienation of immovable property, if any, shall be done with the due and prior approval of the Income Tax Department only in case of Tax exemption is accorded.
- 8) The President shall invest all monies of the trust which may require investment in or upon any one or more of the following securities or more or investments from time to time at their discretion:
- a) Any stock or securities issued of the interest of which government of any state in India.
- b) Fixed or other deposits with any scheduled bank or with any public company registered in India as prescribed by the Income tax Act 1961.
- c) Any immovable property or leasehold interest therein or flat on ownership basis.
- d) Any category of investment in which the President is by the law or the time being free in the union of India authorized to invest such monies.

9) No Funds or other property of the trust shall be paid to or distributed among Trustees but shall be applied towards the furtherance of the trust's objects or for any other charitable purposes. 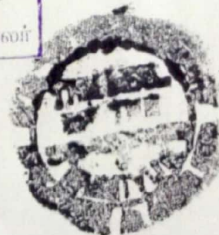
18. To sue or to be sued: The President of the trust shall be entitled to sue or to be sued in the name of Trust.

21. Meetings:

- 1) The BOARD OF TRUST shall meet as often as may be necessary or convenient to transact business that may be held such places as the President may decides so. However there shall be at least one meeting of the BOARD OF TRUST in each financial year.

23. Financial Year: The Financial Year of the Trust shall be from 1st April to 31st March of every year.

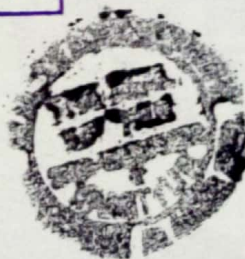
